- 2. Outline of your organization
- (1) Background, vision, strategy, activity In 1994 was born Granahorrar Foundation, emerged from the commitment with vulnerable population, aspirating to be a leader in integrating them to society by supporting productive projects that foster employment of persons whit disabilities.

Its strategy is referred to exploring ways to increase the capacity of vulnerable persons and /or with intellectual disabilities, and in so doing contribute to the wellbeing of them.

It identifies relevant skills on them, and support and carry out strategies for promoting accomplish the maximum potential of every participant.

At this moment Granahorrar Foundation is implementing 3 projects: 7311 (DABS), Fundación Carolina, and ICBF, all of them supporting and capacitating PWID in order to find them better options to get jobs accommodations and improved employment opportunities with the purpose of promote a real inclusion into society.

(2) Mayor programs, covered areas, and target population of your organization

7311 project with the Social Welfare Administrative Department witch based its purpose on accomplish social politics that make promotion, prevention and protection of PWD rights guaranteeing their participation in every community realm. It takes place in Bogotá with citizens on the following boroughs: Candelaria, Rafael Uribe Uribe, San Cristobal, Kennedy, Tunjuelito with 104 PWID as total of beneficiaries.

'he second project in association with Carolina Foundation has as aim Integrate PWD into society all through training them to be productive and promoting their skills and capacities. The total of participants are 102.

The third project is in association of ICBF, with adolescents with ID. All the leading actions of this project are based on the purpose of enhance the abilities of the beneficiaries in order to make them able to perform any productive activity once they become adults.

(3) Target group, number of beneficiaries The target group is composed of adolescents and adults with disabilities and also with low income witch become them part of a vulnerable population of our country. 315 is the total number of the beneficiaries.

(4) Your position and duty

At Granahorrar Foundation I am responsible to design and execute a project dedicated to promote social inclusion of people with intellectual disabilities. Coordinate the family department: leading actions towards personal development and family support through systemic model of intervention, all of that towards improving the economic independence, social empowerment, and community integration of persons with intellectual disabilities.

(1) Outline of the project or program

a) Goal or purpose

7311 Project: Provide Integral Attention to adults with physical or intellectual disability. Promote their participation and give opportunities to reach a productive social inclusion.

b) Expected outputs

Increase life status of PWID

c) Inputs of the implementing organization

Focus our strategies on productivity and on support Micro-entrepreneurs with PWID. Focus on enhance their abilities in order to make PWID able to perform any productive activity.

Offer an integral teaching witch include the improvement of areas such as emotional, social, and occupational.

d) Inputs of Community

It has been increasing an efective and meaningful participation of the community. Many organizations are interested in give job opportunities at individual or groups with intellectual disabilities.

e) Inputs of external agents

The project is connected with major programs from the District: This make an important role on supporting the goals and actions regarding welfare of PWID like culture, recreation and healthcare.

f) Budget and period

The budget of the projects is 400.000 millions on each contract. The period of each contract is 8 months. At this moment Granahorrar Foundation has executed 3 contracts in association with the Social Welfare Administrative Department of Bogotá.

(2) Activities and Consequence

a) The result / consequence (What has happened or been achieved?)
Make alliances with organizations such as Maloka, Bancolombia, Febor, Colsanitas,
Banco Santander, Davivienda, Fondo de Pensiones Públicas among others witch
provide alternatives to the beneficiaries to be included into society.

Also the training focus on productivity has been an opportunity to PWID and their
families become independent and create different working and offer their services as
gardeners, and as micro entrepreneurs (bakery and recycling processing)

 b) Strength and weakness (Good points and the major problems)
 Being a leader in integrating PWID to society by supporting productive projects that foster employment of them is the major strength.
 Offering training in genuine working realms.

The major problems are referred to the community, because there is still a barrier to give opportunities to PWID. Also there is a difficulty with families who want to denial the abilities and skills of the PWID, not encouraging them as independent persons.

c) Process of monitoring and evaluation Social Welfare Administrative Department performs monitoring and evaluation of the project, besides that on every realm on witch beneficiaries are trained there is a constant evaluation of them and of the professionals in order to guarantee the highest of quality according to ISO 9000 standard.

States have obligations with regard to its citizens with intellectual disabilities, accomplish its responsibilities on increasing the number of people attended however would not be able to extend the financial support necessary for independent living for a population for whom are need of centers where they can be trained to be more autonomous. There is a little amount of ONGs dedicated to attend needs of PWID witch make more difficult to achieve welfare in this population and complicate the task of spreading information regarding PWID to the community. Community has a lack of knowledge about PWID and their actual needs.

After diagnosis the children, adolescent or adult with ID are send to ask for a position in a project where their needs will be attend.

One of the problems is the tack of centers dedicated to attend PWID with vulnerable conditions, concerned that creating new institutions as a result of this review process-placing more centres for integration PWID into the community. The government must look at a thorough and appropriate reform of the services to them, and at ways to significantly increase the capacity of the community to support the integration of PWID. A comprehensive reform leading for ONGs should enable people with intellectual lisabilities to fully exercise their right to health care and other social, cultural and economic rights, such as right to education, employment or right to family life. Also is important to make changes in the community in order to offer a true integration into society for PWID, those attitudes could be changed, towards greater acceptance of in the community by leading campaigns on those issues.

1) Characteristics of PWID

As a psychology I have consistent knowledge and experience with PWID: Etiology of ID, conductual phenotype, the cognitive processes, mental and motor development levels, adaptive and maladaptive behavior; all of that assessed by the standard IQ test.

I have knowledge about Human Rights of Persons with Intellectual Disabilities, International rights related to special education and issues in Colombia associated with employment, provision of goods and services, as well as the promotion of equality of opportunity.

As agent of the Social Welfare Administrative Department I have been aware and in contact with the departments in charge of services on mental care, adoption, education, and others programs that guarantee welfare for PWID.

#### 4) Situation of PWID in your country / area

The Situation of Colombians with Intellectual Disabilities is changing however exists discrimination on the basis of disability. There is still many obstacules to rich goals like laws prohibiting employment discrimination on the basis of disability or change the unfounded myths, fears, and stereotypes about PWID.

We have found arbitrary deprivation of liberty, living conditions and lack of adequate conditions at home or at some institutions. Negligence is a common issue in low income families with a member with PWID. These situation is been changed because of the improvement of programs and projects dedicated to support the most vulnerable members of our society.
